All articles submitted for publication are first considered by the Editorial Board and then submitted to the Scientific Committee or to external experts if the article's theme requires it. The final decision to publish an article or refuse it rests solely with the Editorial Board.

Editorial guidelines for bfo-Journal

1. Articles should be submitted in word and should not exceed 30'000 characters (including spaces and notes). Please include the legends of the illustrations and photographic rights at the end of the text.
2. Illustrations (no more than 10) should be sent in jpeg, 72 dpi.
3. The abstract, in word, should not exceed 500 characters (including spaces).
4. The biography, in word, should not exceed 800 characters (including spaces) and should be accompanied by a photography of the author, in black and white (jpeg, 72 dpi), that will be published on bauforschungonline.ch
5. The cover image should be sent in jpeg, 72 dpi.
6. Text should be written in Arial, 12.
7. Illustrations should be sent in a separate file word. Please send illustrations in the following format: jpg, 72 dpi. Corrections of the images using Adobe Photoshop or a similar program is the author's responsibility. Please name illustrations as follow: Author's name 1, Author's name 2, etc.
8. The author is responsible for obtaining the rights to reproduce the illustrations.
9. Footnotes should be included at the bottom of pages.
10. The references in the notes must follow the gta guidelines for British English (<https://verlag.gta.arch.ethz.ch/home-en/downloads>), and should be complete and comprehensible. In case of doubt please consult the editors.
